GOVERNING COUNCIL OF UNITED NATIONS COMPENSATION COMMISSION  
APPROVES AWARDS OF APPROXIMATELY US\$182 MILLION FOR COMPENSATION  
AT ITS FORTY-SIXTH SESSION

The Governing Council of the United Nations Compensation Commission, under the Presidency of Ambassador Sverre Bergh Johansen (Norway), has concluded its forty-sixth session today and approved awards of US\$181,551,055.76 for compensation. Representatives of Kuwait and Iraq addressed the fifteen-member Governing Council at its opening plenary meeting.

The Council approved five reports and recommendations of the panels of Commissioners concerning claims from individuals in category "D", claims from corporations in category "E", and claims from Governments in category "F":

Part one of the fifteenth instalment of category "D" claims (individual claims for losses over US\$100,000) involved 500 claims filed on behalf of individuals by 17 Governments and one international organization. Of these, 445 claims filed by 13 Governments and one international organization were recommended for compensation, with a total award value of US\$129,121,634.76;

The eighth instalment of category "E1" claims (oil sector claims) involved 12 claims filed on behalf of corporations by five Governments. Of these, 11 claims filed by five Governments were approved by the Council for compensation, with a total award value of US\$36,378,070;

The twenty-second instalment of category "E3" claims (non-Kuwaiti construction and engineering claims) involved 13 claims filed on behalf of corporations by nine Governments. Of these, six claims filed by six Governments were approved by the Council for compensation, with a total award value of US\$13,692,464.

The twenty-seventh instalment of category "E3" claims involved 13 claims filed on behalf of corporations by nine Governments. Of these, three claims filed by three Governments were approved by the Council for compensation, with a total award value of US\$851,349.

The fourth instalment of category “E/F” claims (claims filed on behalf of insurance companies and export credit agencies) involved 15 claims filed by six Governments. Of these, two claims filed by two Governments were approved by the Council for compensation, with a total award value of US\$1,507,538;

The Council discussed a progress report of the Executive Secretary on the activities of the Commission. The report addressed the processing of claims and the payment of approved awards.

The Council also discussed the report of the Executive Secretary on the distribution by Governments of payments to successful claimants, the transparency of the distribution process, and the return of undistributed funds.

The Council decided to hold its next regular session from 11 to 13 March 2003.

To date, the Commission has awarded compensation of over US\$43.7 billion, including the awards approved in the forty-sixth session; over US\$16 billion of the amount awarded has been made available to Governments and international organizations for distribution to successful claimants in all categories of claims.

The session just concluded was the last session for the delegations of Colombia, Ireland, Mauritius, Norway and Singapore whose terms of office end on 31 December 2002. As of 1 January 2003, the five new members of the Security Council, Angola, Chile, Germany, Pakistan and Spain, will be joining the Governing Council for two-year terms.

At the closing plenary, a number of Council members, as well as the Executive Secretary, expressed their profound appreciation to Ambassador Sverre Bergh Johansen for his leadership of the Council over the past two years and, in particular, for his contribution to the maintenance of the Council’s tradition of decision-making by consensus.
